ARTICLE I. CORPORATE NAME AND ADDRESS.



ARTICLE IX. AMENDMENT.

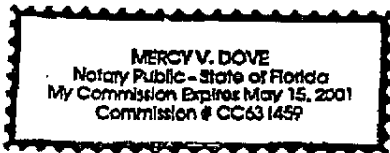
