#### ARTICLES OF INCORPORATION

OF

## TONY STALNAKER CONSTRUCTION, INC.

### ARTICLE I

The name of this corporation shall be Tony Stalnaker Construction, Inc.

## ARTICLE II

This corporation shall have perpetual existence.

#### ARTICLE III

The primary purpose of this corporation shall be to engage in the business of operating a construction company and the transaction of any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida.

#### ARTICLE IV

The amount of capital stock authorized shall be 100 shares of common stock having a par value of \$1.00 Dollar (\$) per share, making a total authorized capital stock of One Hundred Dollars (\$100.00).

## ARTICLE V

The management of the corporate affairs of this corporation shall be managed by the Board of Directors.

The number of directors constituting the initial Board of Directors shall be not less than one (1) nor more than five (5).
