
Dear Sir or Madam:


The purpose of this letter is to request reinstatement of the corporation, McLucas, Inc., and to request consideration of waiving the reinstatement fee of \$600.00. The owner/shareholder and director of the corporation, Marlen Lucas, was from Venezuela and has indicated two possible reasons why the original 2001 Uniform Business Report was not filed.

1. She did not receive the original form and due to the fact that she had lived in the U.S. for no more than two years, she was not familiar enough with Florida laws to inquire as to why no 2001 Uniform Business Report had not been received.
2. Being from Venezuela and not having a real good grasp of the English language yet, Ms. Lucas indicated that she may have thought the use of the word "UNIFORM" on the front cover of the report package was a solicitation to purchase uniforms for the company's employees, and not being interested in uniforms, threw the report package away by mistake.

In closing, Ms. Lucas honestly thinks the second reason above was truly what happened and the error occurred because of her lack of understanding of the English language when her native language is Spanish. Therefore, we are requesting your consideration to the waiving of the reinstatement fee. A check for \$158.75 is being enclosed with the application for reinstatement representing the Annual Report Fee, the Corporate Supplemental Fee, and the fee for a Certificate of Status.
