#### ARTICLES OF INCORPORATION OF ELECTRIFIED SERVICE & DATA, INC.

SECULATION OF THE PARTY OF THE The undersigned natural person hereby forms a corporation in accordance wi the laws of the State of Florida, and hereby adopts the following Articles of Incorporation for such corporation:

#### Article I - Name

The name of the corporation is ELECTRIFIED SERVICE & DATA, INC.

#### Article II - Duration

The corporation shall have a perpetual existence. The date and time of commencement of corporate existence is April 1, 1999, for accounting purposes only.
