ARTICLES OF INCORPORATION  
OF  
BLUE AND GOLD GROUP INC.  
A FLORIDA PROFIT CORPORATION

THE INCORPORATOR OF THE ABOVE-NAMED CORPORATION, PURSUANT TO THE FLORIDA GENERAL CORPORATION ACT, ADOPT THESE ARTICLES OF INCORPORATION AND PROVIDE:

1. THE NAME OF THE CORPORATION SHALL BE BLUE AND GOLD GROUP INC. WHOSE PRINCIPAL OFFICE SHALL BE 645 W. CHASE STREET HERNANDO, FLORIDA 34442.
2. THAT THIS CORPORATION SHALL HAVE A PERPETUAL EXISTENCE, WHICH SHALL COMMENCE ON THE DATE OF THE EXECUTION AND ACKNOWLEDGEMENT.
3. THAT THE PURPOSE OF THE CORPORATION SHALL BE TO TRANSACT ANY OR ALL LAWFUL BUSINESS FOR WHICH CORPORATIONS MAY BE INCORPORATED UNDER THE LAWS OF THE STATE OF FLORIDA.
