ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby for a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

ARTICLE 2 - PURPOSE OF CORPORATION

ARTICLE 6 - CORPORATE CAPITALIZATION

- 6.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is **SEVEN THOUSAND FIVE HUNDRED** (7,500) Shares of common stock, each share having the par value of ONE DOLLAR (\$1.00).
