ARTICLE I. NAME

NAME: The name of this corporation is PRECISION CABINET & CARPENTRY,
INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the 1st day of
July, 1999.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of the construction and installation of
cabinets and other non-structural carpentry, and transacting any and all other lawful business
in the State of Florida and the United States of America.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of (\$1.00) par value common
stock.

ARTICLE V. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the
same kind, class or series as that which he already holds, shall have the right to purchase his
