ARTICLE IV

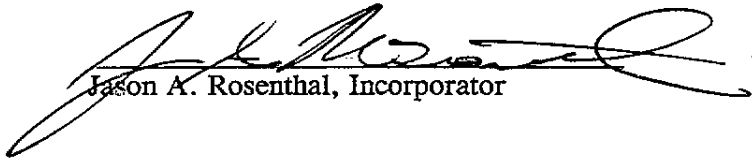

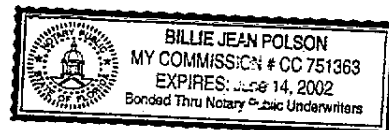
