ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

Article I: The name of the Corporation is Siteline Land Surveying Corporation.

Article II: Corporation's principal office is located at 4029 East Ridge Circle, Pompano Beach, FL 33064

Article III: The purpose or purposes for which the Corporation is organized are to engage in any activity of business permitted under the laws of the United States and of the State of Florida.

Article IV: The aggregate number of Shares that the Corporation shall have the authority to issue is 200 Shares of Capital Stock with a par value of \$0.25 per Share;

Initial Issue: 200 Shares of the Capital Stock of the Corporation shall be issued at a Par Value of \$0.25 per share;

Stated Capital: the sum of the Par Value of all shares of Capital Stock of the Corporation that have been issued shall be the stated Capital of the Corporation at any particular time;

Dividends: The holders of the outstanding Capital Stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the Capital Stock of the Corporation;

No Classes of Stock: The Shares of the Corporation are not to be divided into Classes;

No Shares in Series: The Corporation is not authorized to issue Shares of stock in Series.

Article V: The initial street address in Florida of the initial Registered Office of the Corporation is 4029 East Ridge Circle, Pompano Beach, Florida 33064, and the initial Registered Agent shall be Christopher A. Moschillo, located at 4029 East Ridge Circle, Pompano Beach, Florida 33064.

Article VI: The initial Board of Directors shall consist of two (2) Members who need not be a resident of the State of Florida or a Shareholder of the Corporation.

Article VII: The name and address of the persons who shall serve as Directors until the first Annual Meeting of Shareholders, or until their successors shall have been elected and qualified, are as follows:
