The effective date upon which this corporation shall come into existence is June 29, 1999 and it shall exist perpetually thereafter unless dissolved according to law.

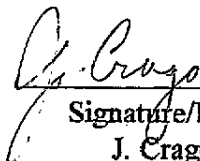

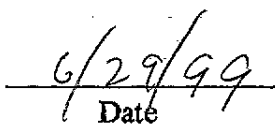
