On behalf of Ace Productions, Inc., the intent of this letter is to inform the above mentioned addressee of the "mailing retrieving" problem that we have been having (the ability to get our mail), thus explaining why we have been tardy in paying the filing fee for the annual report/uniform. There are actually three reasons or explanations why we did not get your notice in time. One, there is another house with the address of 320 N.E. 23<sup>rd</sup> street (a back house) which our mail gets delivered to from time-to-time causing us to have to ask the neighbor for our mail, continuously. Two, we have been lucky enough to work out of town most of this season do to the nature of our business, which means that our "wrongly" delivered mail gets either lost or just simply returned to the sender. And, three our mailbox system is very unsecured, meaning that anybody can take our mail. It is located in an alley behind our house and unsheltered from rain (hurricane season, Florida) and the mailbox has no locking system. I have included a photo, which was recently taken. We are trying to resolve these problems at the present time. In consideration, I am asking that you review our situation, which will explain why our first notice of payment due never got our attention. We actually received the second notice (our first) weeks after the notice was past due. Thank you for your time.
