ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF IPLACEMENT.COM, INC.

Pursuant to the requirements of Sections 607.1003 and 607.1006, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Articles of Incorporation of IPLACEMENT.COM, INC.
