ARTICLES OF INCORPORATION

OF

TALLAHASSEE, FLORIDA

PANAMA CITY LOCAL'S, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST:

The name of the corporation is Panama City Local's, Inc. The mailing address of the corporation is 1 Emerald Lake Drive, Panama City Beach, Florida 32407.

SECOND:

The corporation is to commence its corporate existence on the date of the filing of these articles with the Florida Department of State, and the period of duration of the corporation is perpetual.

THIRD:
