**ARTICLES OF INCORPORATION
OF
ANDAW HOLDINGS INC.**

The undersigned, for the purpose of forming a corporation for profit under the laws of the state of Florida, hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation is : **ANDAW HOLDINGS INC.**

ARTICLE 11

DURATION

This corporation shall have perpetual existence unless dissolved pursuant to the law and shall commence as of the date of filing of these Articles of Incorporation.

ARTICLE III

PURPOSE

This corporation may engage in any activity of business permitted under the laws of the State of Florida, its primary purpose to be real estate investment.

ARTICLE IV

CAPITAL STOCK

This corporation is authorized to issue 100 shares of \$1.00 par value common stock.

ARTICLE V

PREEMPTIVE RIGHTS

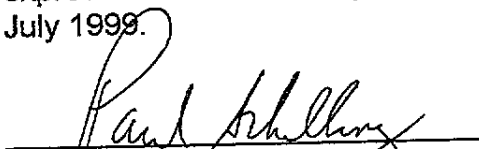
