**ARTICLES OF INCORPORATION  
OF  
SRIPAL CORPORATION**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

**ARTICLE ONE**

NAME

The name of the corporation is SRIPAL CORPORATION.

**ARTICLE TWO**

CORPORATE DURATION

The duration of the corporation is perpetual.

### **CAPITALIZATION**
