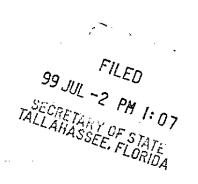

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is GLOBALLINK 2000, INC., and the principal office or mailing address of the corporation is 5876 Folkstone Lane, Orlando, Florida 32822.

ARTICLE II - DURATION
