ARTICLES OF INCORPORATION
OF
GLOBALLINK 2000, INC.

ARTICLE I - NAME

The name of this corporation is GLOBALLINK 2000, INC., and the principal office or mailing address of the corporation is 5876 Folkstone Lane, Orlando, Florida 32822.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of 1.00 par value common stock which shall be designated as "Common Shares."

ARTICLE V - PRE-EMPTIVE RIGHTS

The Corporation elects to have preemptive rights. Every shareholder, upon the sale for cash of any new or unissued stock of this corporation, shall have the right to purchase his

pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is Orlando, Florida 32822, and the name of the initial registered agent of this corporation at that address is Richard W. Gault.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

The corporation shall have 1 Director constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by the By-Laws; however, there shall never be less than one Director nor more than five. 


