**ARTICLE I. NAME**

The name of the Corporation is: **Fast Appraisal Services, Inc.**

The Corporation's business address is 3370-I Capital Circle N.E., Tallahassee, Florida 32308. The Corporation's business shall be conducted in the United States, in its possessions and in all foreign countries, wherever necessary or convenient.

**ARTICLE II. DURATION OF CORPORATION**

The duration of existence of this corporation is and shall be perpetual or until dissolved according to law.

**ARTICLE III. PURPOSE**

The general purpose of the business or businesses to be transacted, conducted and carried on by this corporation shall be to engage in any activity or business permitted under the laws of Florida.

**ARTICLE IV. CORPORATE POWERS**


