

ARTICLES OF INCORPORATION OF
NAUTICA COAST INDUSTRIES, INC.

1. Name. The name of the corporation is: NAUTICA COAST INDUSTRIES, INC.
2. Purpose. The corporation may engage in any legal business.
3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 10,000,000 shares of common capital stock with no par value.
