The undersigned, being a duly licensed dentist in the state of Florida, for the purpose forming a professional corporation under Chapter 607 of the Florida Statutes, and Chapter 621 of the Florida Statutes, being the professional Service Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be:

ARTICLE II. NATURE OF BUSINESS

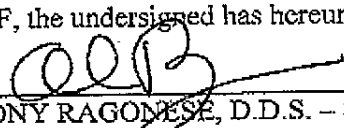
