Dear Reinstatement Manager,

"Grapevine Communications International, Inc." was incorporated as a type "S Corp." in July 1999. In 2000, I filed my annual documents which stated at the time, that the company had been "inactive" for that previous fiscal year.

In early June 2001, I moved from 8347 Whispering Woods Court, Bradenton, Florida to a new address. I never received any other annual filing form. My attorney said I did not need to worry about filing the form, as the company was still "inactive".

The attorney that did the incorporation papers for me was both on retainer with my previous employer, as well as a personal friend. As I left that employer "not on the best of terms", the attorney has had no further contact with me. I requested in December 2001 for my minute book to be returned to me and received it on January 8, 2002. Enclosed with my minute book was a letter informing me that my company had been "administratively dissolved" on September 21, 2001.

I had no idea this had happened. I am not certain if the change of address had ever been forwarded to the Division of Corporations. As the attorney feels there is a "conflict of interest" if he continues working with me, he has advised me to seek counsel at another firm.

I called your offices last week and spoke with Kathy who advised that I complete the reinstatement form enclosed and accompany it with a check for \$150.00 for last year's filing. I hope you will look favorably on my company as I am just "opening my doors" for business. I have already opened bank accounts using the tax I.D. number (59-3601617) I had been issued, believing that the company was still a viable entity.
