**ARTICLES OF INCORPORATION
FOR
DDT SOUTH, INC.**

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

Richard Stevens and Pamela Stevens whose address is 65880 Overseas Highway, Long Key, Florida 33001 shall serve as initial directors.

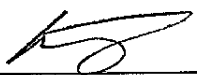
**ARTICLE VIII
