NAME AND ADDRESS**

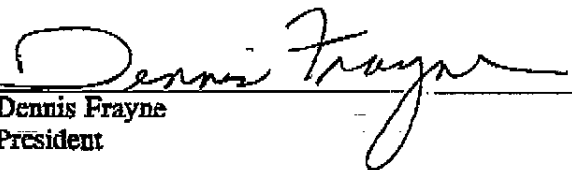
