ARTICLES OF INCORPORATION
OF
DIGITAL ONLINE ASSOCIATES, INC.,
a Florida corporation

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation (hereinafter the "Corporation") is Digital Online Associates, Inc.

ARTICLE II

EFFECTIVE DATE

07-05-99

The existence of the Corporation shall begin on July 5, 1999

ARTICLE III

The street address of the principal office of the Corporation is 2435 7th Avenue North, St. Petersburg, Florida 33713.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 5,000, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V


