The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

- 1. The name of the corporation is: KRIS-B CORP.
- 2. <u>Purpose:</u> The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

- 4. The corporation shall have the authority to issue 1,000 shares of common stock, in one class only, each with a par value of \$0.10.
