**ARTICLES OF INCORPORATION
OF
SOMEWHERE ON LOCATION, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I. NAME

The name of the corporation ("Corporation") shall be:

SOMEWHERE ON LOCATION, INC.

The street address of the principal office of the Corporation shall be 39322 U. S. Highway 19 North, Tarpon Springs, Florida 34689, and the mailing address shall be the same.

ARTICLE II. TERM OF EXISTENCE

This Corporation perpetual existence commencing on the date of execution and acknowledgement of these Articles.

ARTICLE III. REGISTERED AGENT

The initial street address of the Corporation's registered office is 39322 U. S. Highway 19 North, Tarpon Springs, Florida 34689. The initial registered agent for the Corporation at that address is ARTHUR D. DECKELMAN.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares this Corporation is authorized to issue is 400 Shares, all of which shall be Common Shares, having \$1.00 par value per share. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.
