APRIL 27, 2001**

GUARDIAN INTERNATIONAL, INC., a corporation organized and existing under  
and by virtue of the Florida Business Corporation Act,

DOES HEREBY CERTIFY:

1. The name of the corporation is Guardian International, Inc.
2. That the Articles of Amendment to Articles of Incorporation were filed with the Secretary of State of Florida on April 27, 2001 and that said Articles of Amendment require correction as permitted by Section 607.0124 of the Florida Business Corporation Act.
3. The inaccuracy or defect of said Articles of Amendment to be corrected is as follows:

The date set forth in Article III, Section 8(c)(ii) should read April 27, 2001.

4. Article III, Section 8(c)(ii) is corrected to read as follows:

(ii) Redemption Upon a Happening of Certain Event. A holder of Series E Preferred Stock may elect to cause the Company to redeem its shares of Series E Preferred Stock for an amount in cash equal to the Redemption Price upon the occurrence of an event triggering a redemption right pursuant to Section 7(c)(ii) of Article III herein. Any and all rights provided for in this Section shall terminate upon the transfer of the Series E Preferred Stock by a holder of such stock as of April 27, 2001 to any person who is not an affiliate of Western Resources, Inc., a Kansas corporation, or of such holder.
