ARTICLES OF INCORPORATION

TALLAHASSEE, FLORIDA

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

- Article 1. Name. The name of the Corporation is: TARAN MARKETING CONSULTANTS CORP. The principal office and the mailing address of the Corporation is 200 E. Robinson Street, Suite 500, Orlando, Florida 32801.
- Article 2. Duration. The duration of the Corporation is perpetual.
