ARTICLE I - NAME

The name of the Corporation is Kennedy Lawn Sprinkler II, Inc

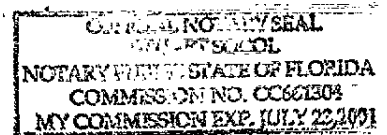
