

ARTICLES OF INCORPORATION

### RENTALEX OF HUDSON, INC.

### ARTICLE I NAME

The name of the Corporation is RENTALEX OF HUDSON, INC. The address of the Corporation is 1022-1028 Skipper Rd. Tampa, FL 33613.

### ARTICLE II DURATION

The Corporation shall have perpetual existence.

### ARTICLE III PURPOSE
