**ARTICLE ONE
NAME**

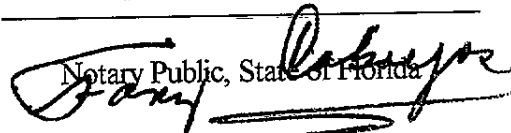
