### ARTICLE I

#### NAME

The name of this corporation shall be GULF COAST RESTAURANTS, INC., hereinafter referred to as the corporation.

### ARTICLE II

#### DURATION

The corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Florida Department of State.

# ARTICLE III

### PURPOSE


