INDEMNIFICATION

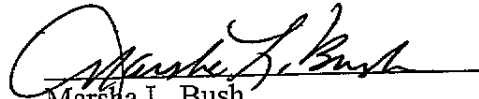

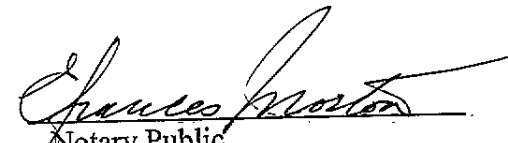
