Gentlemen:

On March 3, 2001, Mr. David Johnson, the secretary treasurer of J-CUBE, Inc., died suddenly, apparently of a massive heart attack. J-CUBE, Inc. is a subchapter S corporation, initially comprised of three shareholders including Mr. Johnson; its purpose was to formalize a 3-way joint ownership of a light airplane.

Within a month of Mr. Johnson's death, his heirs passed to us several boxes of the records he had maintained for the corporation. We examined these records and determined he had properly filed both the state and federal income tax returns for the year 2000. At that time we did not see the 2001 uniform business report initial mailing (due by May 1, 2001) in these records nor did we realize he had not filed this report.

We received just yesterday from his heirs the last mailing for this report with a 12 September due date and a \$400 penalty. Upon reexamining the files yesterday we did locate the initial notice, which had been misfiled in the book containing the historical records of the corporation. There is a post-it note in Mr. Johnson's handwriting saying "Due before 1 May 2001." It is now clear he died before submitting this report and we did not discover that fact in our initial review of these records.

In the answer to one of your most frequently asked questions in the UBR instructions, you state, "Reports filed after 1 May **are subject to a \$400 late fee**" (Emphasis added). Our question is whether your office has some discretion in imposing that penalty if there are extenuating circumstances. We have been careful to comply with all the requirements of the State of Florida until Mr. Johnson's tragic demise. \$400 represents a significant financial penalty to this small corporation; any adjustment that might be made would be genuinely appreciated.
