Pursuant to Section 607.1105 of the Florida Business Corporation Act, Perfumery Nily, Inc., a Florida corporation ("Perfumery Nily" or the "Parent Corporation"), hereby adopts the following Articles of Merger for the purpose of merging Perfumery Nashville, Inc., a Tennessee corporation ("Perfumery Nashville" or the "Subsidiary Corporation"), into Perfumery Nily (the "Merger"):

Plan of Merger: FIRST:

PLAN OF MERGER

THIS PLAN OF MERGER, providing for the merger of Perfumery Nily, Inc., a Florida corporation (the "Parent Corporation"), and its wholly owned subsidiary Perfumery Nashville, Inc., a Tennessee corporation ("Perfumery Nashville" or "Subsidiary Corporation"), is adopted as of December 12, 2000, by the sole director of the Parent Corporation:

Section I

Names of Parent and Subsidiary Corporation

The name of the parent corporation is Perfumery Nily, Inc., and the name of the subsidiary corporation is Perfumery Nashville, Inc. The Subsidiary Corporation shall be merged with and into the Parent Corporation with the Parent Corporation as the surviving corporation (the "Merger").

Section II

Conversion of Shares of Subsidiary Corporation

Upon the effectiveness of the Merger, each share of the Subsidiary Corporation shall, by virtue of the Merger, and without any action on the part of the holder thereof, be cancelled. The articles of incorporation of the Parent Corporation shall be the articles of incorporation of the surviving corporation.

The Subsidiary Corporation is a wholly owned subsidiary of the Parent Corporation.

Effective Date

The Merger shall be effected by the filing of articles of merger with the Tennessee Secretary of State and the Florida Department of State. The Merger shall be effective on December 31, 2000.
