**ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of MARBERRY & MARBERRY ENTERPRISES, INC., adopts the following Articles of Incorporation to form a for profit corporation under the laws of the State of Florida.

**ARTICLE I
NAME**

ARTICLE VI
INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VII
BOARD OF DIRECTORS

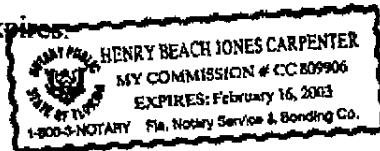
