Pursuant to Section 617.1403 Florida Statutes, Custom Curbing, Inc. submits the following Articles of Dissolution:

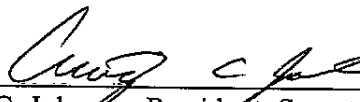
The name of the corporation to be dissolved: Custom Curbing, Inc. Its Florida corporation number is P99000062986.

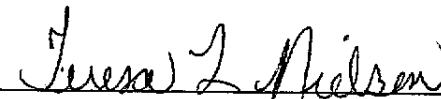
