
These Articles of Dissolution are filed pursuant to Section 607.1403 of the Florida Business Corporation Act, and provide as follows:

1. The name of the corporation is FLORIDA UROLOGY IPA, INC. (the "Corporation").
2. The Corporation was formed in the State of Florida on July 15, 1999, under Charter No. P99000062988.
3. 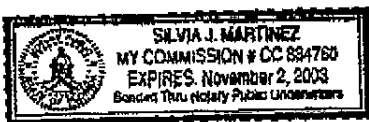
