ARTICLES OF INCORPORATION

OF

ARTICLE ONE

The name of this corporation is HANG TEN FOODS, INC. and the mailing address of the corporation shall be 11701 Pinewood Lakes Drive, Fort Myers, FL 33913.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

ARTICLE THREE

The duration of the corporation is perpetual.

ARTICLE FOUR

The general purposes for which the corporation is organized are:
