ARTICLE I - NAME

The name of this corporation is: **ZIGMA CARGO, INC.** with the principal place of business located at: 10843 NW 29TH STREET, MIAMI, FL. 33172.

ARTICLE II - PURPOSE

This corporation shall have perpetual existence and may engage in any and all lawful business under the laws of the United States and the State of Florida.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 600 shares of one dollar par (\$1.00) par value common stock.
