ARTICLES OF INCORPORATION

OF

PARKER CONSULTING GROUP, INC.

I, the undersigned, hereby organized for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the said State of Florida, providing for the formation, rights, privileges, immunities of corporations for profit.

ARTICLE I

The name of the corporation shall be Parker Consulting Group, Inc.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE III

The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be One Hundred (100) shares authorized at \$1.00 par value each, which shares will be common stock.

ARTICLE IV

The amount of capital with which the corporation will begin business shall be \$100.00.

ARTICLE V

The corporation shall have perpetual existence.

ARTICLE VI
