ARTICLE 1

(NAME)

THE NAME OF THE CORPORATION IS FRANKS CAR CARE SOUTH, INC..

ARTICLE 2

(NATURE OF BUSINESS)

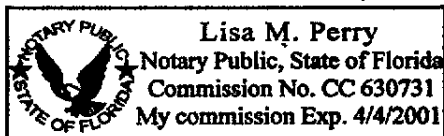
