ARTICLES OF INCORPORATION

OF

JOLEE, INC.

ARTICLE I

Name and Address

The name of this corporation is JOLEE, INC., whose place of business is located at 3415 West Hillsborough Avenue, #737, Tampa, Florida 33614.

ARTICLE II

Duration

The term of existence of this corporation shall be perpetual.

Purpose

Capital Stock

This corporation is authorized to issue One Thousand (1,000) shares at One Dollar(s) (\$1.00) par value common stock, which shall be designated "common shares". This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act, and, in addition to and not in limitation thereof, this corporation shall have the power to guarantee the performances of obligations of other persons, partnerships, corporations, or other entities.

## ARTICLE XI

### Indemnification


The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


