**ARTICLE VI: TERM OF EXISTENCE**

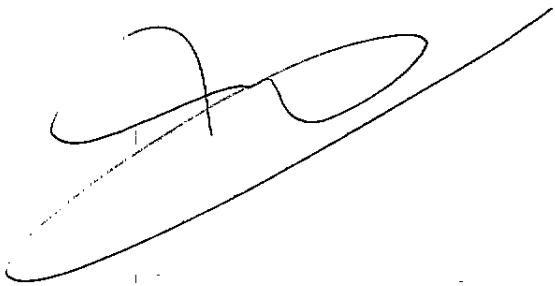
