The power to adopt, alter, amend, or repeat Bylaws shall be vested in the stockholders, and except to the extent limited by the shareholders, is the Board of Directors.

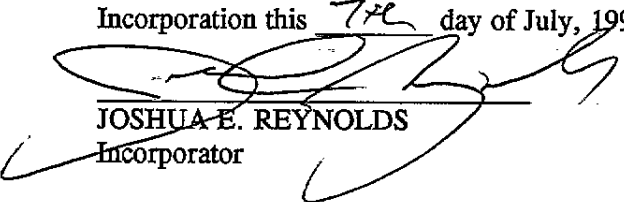
ARTICLE IX - DURATION

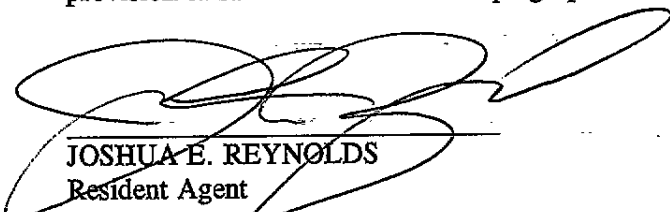
