ARTICLES OF INCORPORATION

OF

MEDICAL AND PROFESSIONAL TELECOMMUNICATIONS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the Corporation shall be: MEDICAL AND PROFESSIONAL TELECOMMUNICATIONS, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 5950 Pelican Bay Boulevard, Naples, Florida 34108. The mailing address of this corporation shall be 838 Neapolitan Way, PMB 301, Naples, Florida 34103.

ARTICLE III SHARES

The authorized capital stock of this Corporation shall consist of 7,500 shares of Common Stock with a par value of \$1.00 per share.
