ARTICLES OF INCORPORATION

TALLAHASSEE, FLORIDA

OF

UNDERGROUND DIRECTORY SERVICE, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE ONE

The name of the corporation is: **UNDERGROUND DIRECTORY SERVICE**, **INC**.

The principle address of the corporation is: 1730 S. Federal Hwy., Ste. 240, Delray Beach, FL 33483.

ARTICLE TWO

This corporation shall commence its existence upon filing and shall exist perpetually thereafter unless sooner dissolved according to law.
