**ARTICLES OF INCORPORATION**

The undersigned subscriber to these Articles of Incorporation, Mary Beth Wise, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

**ARTICLE I**

**CORPORATE NAME**

The name of this Corporation is NEEDLE WISE DESIGN, INC. The principal office and mailing address of the corporation is 23145 W. Eldorado Avenue, Bonita Springs, Florida 34134-7202.

**ARTICLE II**

**DURATION**


