THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A CORPORATION UNDER AND PURSUANT TO THE LAWS OF THE STATE OF FLORIDA, AND ANY AMENDMENT THEREOF, ADOPT THE FOLLOWING ARTICLES OF INCORPORATION.

ARTICLE I

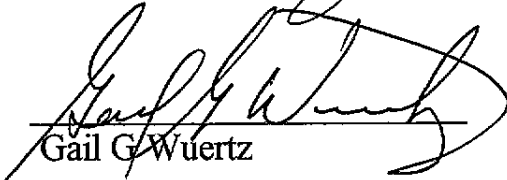

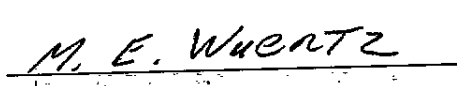
