The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I – NAME

The name of the corporation is L & J Carpentry, Inc.

ARTICLE II – PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 1410 SW 12th Ave., Pompano Beach, Florida, 33069.

ARTICLE III – SHARES

The capital stock of this corporation shall be 100 shares of common stock having a par value of \$1.00 per share. These shares of stock shall be designated as "Common Shares" and shall be the sole class of stock that this corporation is authorized to issue.

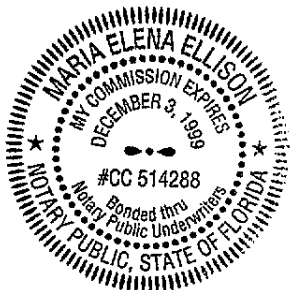
